Cropac Equipment Inc.
Credit Policy

- Cropac Equipment Inc. will establish a line of credit for each customer subject to availability of credit history, information, relations, and reports.
- All credit advanced to the Customer from time to time for the supply of parts and service shall be payable on a net 30 day basis from receipt or performance thereof, as the case may be regardless of receipt of any invoice by the customer.
- A 2.0% cash discount may be deducted from parts and service invoices if paid in full by the 20th of the month following invoice date.
- Statements must be paid in full (all previous months invoices) prior to the end of the month in which the statement is received in order to keep the account in good standing. Failure to do so may result in credit privileges being suspended until such time as payment is resolved.
- All machinery, equipment, attachments and rentals are payable upon receipt of goods unless otherwise stated.
- All credit advanced to the Customer from time to time for the supply of goods, services, machinery and equipment or any of them, or the balance thereof shall, if unpaid, bear interest and the Customer shall pay interest thereon from the end of the month following advancement of such credit at a rate of interest of two per centum (2%) per month, being a nominal rate of interest of twenty four (24%) per annum with interest on unpaid interest at the aforementioned rate.
- Unless written instructions to the contrary are delivered to the Credit department of Cropac Equipment Inc. the verbal authorization of any office, employee, or agent of the customer shall be sufficient authority for the supply of goods, services, machinery and equipment or any of them on credit and Cropac Equipment Inc. shall not be bound to enquire as to the authority of such office, employee or agent.
- Interest rates subject to change, and notice provided to the Customer is deemed acceptance.

In addition, Cropac Equipment Inc. is pleased to accept Visa, Master Card and Amex
(At point of purchase only, and cash discounts do not apply).

I, the undersigned, declare that all the information supplied in this credit application is true and accurate, that I am authorized to request a charge account at Cropac Equipment Inc. Furthermore by signing hereunder this Credit form, I agree and consent to authorize Cropac Equipment Inc. to obtain from any credit reporting agency or any other source, such information as Cropac Equipment Inc. may deem appropriate, at any time in connection with the credit hereby applied for.
